NOTES

1. Please notify Fischy Ltd if you change your name or address while the declaration is still in force.
2. You can cancel the declaration at any time by notifying Fischy Ltd in writing—it will then not apply to donations you make on or after the date of cancellation, or such later date as you specify.
3. You must pay an amount of income tax and/or capital gains tax at least equal to the tax that Fischy Ltd reclaims on your donations in the tax year (currently 28p for each £1 that you give).
4. If in the future your circumstances change and you no longer pay tax on your income and/or capital gains tax equal to the tax that Fischy Ltd reclaims, you can cancel your declaration (see note 2).
5. If you pay tax at the higher rate you can reclaim further tax relief in your Self Assessment tax return.
6. The declaration does not apply to gifts given through Give As You Earn, Charities Aid Foundation (CAF) or Charitable Giving Scotland (CGS), on which tax has already been reclaimed.
